



## What You Should Know About the Cruise

### ***Age Requirements***

All winners must be over the age of 18. There are no minimum age restrictions for the guest.

### ***ID Requirements***

A valid form of ID will be required for both the winner and guest for cruise booking and to board the ship for sailing. Valid forms of ID include a current passport or BOTH a valid state photo ID AND an original birth certificate.

### ***Use of a Proxy***

If for any reason the original prize winner and/or guest cannot attend the Power Cruise sailing on 01/15/2018, they may assign a Proxy to sail in their stead. This must be determined 30 days prior to sailing.

At the request of a prize winner and with the approval of the South Dakota Lottery, the Contractor shall make necessary arrangements for a winner to transfer the trip ONCE prior to booking deadline at no additional cost to the Lottery or the winner. The prize winner shall remain subject to tax reporting and tax withholding even if they transfer the prize.

If the need for a Proxy is determined prior to booking any travel arrangements for the original prize winner, there will be no additional costs incurred to the winner.

If the need for a Proxy is determined after travel booking arrangements have been made for the original prize winner, the winner will be responsible for all additional expenses incurred for booking travel for the Proxy.

Proxy paperwork must be submitted by Saturday 12/16/2017.

### ***What if I miss the boat?***

If the winner and/or guest don't board the ship in time for sailing, there will not be an alternate sail date provided or credit towards another cruise trip with Royal Caribbean International®, and the winner will not receive any reimbursement for the trip value. The original prize winner will still be eligible to win the top prize of \$50,000 and/or a \$500 debit card (both to be awarded to the winner after the sailing).

### ***Do I need a credit card?***

A personal credit card will be required upon ship check-in to have on file to put towards additional onboard spending above the \$250 included ship credit from the Power Cruise prize package. This card will only be charged if the ship credit of \$250 is exceeded. Ship credit of \$250 is non-refundable and must be used during the cruise.

### ***Declining the Prize***

Prize winners who decline the Cruise Prize shall not be subject to tax reporting or withholding.

### ***Taxes***

Prize winners who accept the airfare booking and /or the cruise shall be subject to tax reporting and withholding regardless of whether they actually take the air flight and /or the cruise. Prize winners who do not elect to take a guest or whose guest does not actually take the flight and /or cruise are subject to the full prize reporting and withholding.

### ***Onboard Prizes***

Onboard prizes of \$100,000 will be awarded in the form of \$500 prepaid debit cards and distributed onboard the ship. The \$50,000 grand prize winner will receive a check in the mail within 14 business days after the return of the ship.

The winner of the \$50,000 cash prize may be subject to each Lottery's debt set off requirements; the Contractor will process the check once written approval is received from Lottery.

If a Proxy is assigned and accepts the cruise trip prize, the proxy will not be eligible for the onboard cash prizes (\$500 pre-paid debit cards or the \$50,000 cash grand prize). The original prize winner will receive the cash prize if selected and receive their prize via mail at the conclusion of the cruise.

### ***Is there a cash option?***

The Power Cruise trip prizes will not have a cash option or a partial cash value.

### ***Travel Insurance***

Winners will not be required to purchase travel insurance but will have the option to do so if they choose through the Contractor during the booking process.

If a winner or guest misses their flight and has not purchased supplemental travel insurance, the winner will be responsible for any additional flight or travel costs to make the ship departure or return home.

If a winner misses the departure time of the ship and has not purchased travel insurance there will be no credit or rebooking of the cruise. It is the sole responsibility of the winner to arrive at the port of call in advance of the departure time.

***Additional Fees or Charges***

The Power Cruise Prizes do not include any additional fees or charges such as additional travel expenses, expenditures for excursions, ATM fees, supplementary gratuities, premium dining experiences, late night room service charges, etc. These are made to the stateroom during the duration of the cruise, and totaled upon departure and checkout.

***Each Power Cruise Package Consists of:***

<i>Hotel</i>	One (1) night accommodations (including hotel taxes) for two (2) at a deluxe hotel in the port city for the night prior to cruise departure.
<i>Cruise</i>	Five (5) nights aboard the Royal Caribbean® “ <i>Brilliance of the Seas®</i> ” departing from the Port of Tampa to 2 port of call destinations, Key West, FL and Cozumel, Mexico.
Ship’s Credit (\$250)	Prizewinner will be provided with a non-refundable \$250 credit applied to their ship account to be utilized for incidental items such as: beverage service, shore excursions, specialty dining, casino gaming and purchases made during the cruise and/or similar expenditures.
<i>Miscellaneous</i>	All primary gratuities on the ship (room attendant & dining room staff) and all trip related destination/departure taxes are also included.
