



SOUTH DAKOTA LOTTERY DRAWING GUIDELINES

JAMES BOND Lottery Challenge 2nd Chance Drawing February 3, 2020 – Summer 2021

The **JAMES BOND Lottery Challenge** is a second chance drawing available to South Dakota Lottery Players Club members. Players can enter non-winning **JAMES BOND 007™** tickets for a chance to win a Las Vegas trip for two (2) to compete in the **JAMES BOND Lottery Challenge** for a chance to win \$1 million or more. The drawing will have one winner.

These drawing guidelines have been prepared to ensure the prizes awarded for the **JAMES BOND Lottery Challenge** 2nd Chance Drawing are determined as impartially and randomly as possible and that the integrity of the South Dakota Lottery is maintained at all times.

The Executive Director of the South Dakota Lottery reserves the right to change and supersede any outlined procedures to handle unforeseen circumstances.

Second Chance Drawing Rules

- A. To be eligible for the drawing, the entrant must be a member of the Players Club.
- B. To become eligible for the drawings, players must enter a non-winning **JAMES BOND 007™** ticket that has not previously been entered for any other Lottery drawing by accessing the Players Club website at <http://lottery.sd.gov/players/login/> or through the official SD Lottery app.
- C. Each ticket will receive one entry. Entries will be accepted until the entry cutoff time of 11:59 p.m. CST the night before the posted drawing dates as shown on the Lottery website.
- D. The winners of the **JAMES BOND Lottery Challenge** 2nd Chance Drawing will be determined at a publicly held drawing at the Pierre Lottery office in accordance with SDCL Chapter 42-7A, Lottery administrative rules, and these **JAMES BOND Lottery Challenge** Drawing Guidelines.
- E. The odds of an entrant being selected as a **JAMES BOND Lottery Challenge** 2nd Chance Drawing winner will be determined by the number of entries submitted.
- F. One (1) Winners and ten (10) alternates will be randomly selected during the drawing. Winners will have ten (10) days from the date they are notified of their win



to submit their confirmation information to receive their prize; should that deadline not be met, the prize will revert to the next alternate.

- G. Should the security and integrity of the Players Club webpage be comprised by technological intrusion or other like actions, the promotion will be suspended until such time as said security has been reinstated and verified.
- H. In the event that the South Dakota Lottery is unable to conduct the drawing, due to technological issues or other like circumstances, the Multi-State Lottery Association (MUSL) has been authorized to perform the drawing in a back-up capacity, utilizing the procedures and processes contained in these guidelines.

Prize Terms and Conditions

A. The prize is a five-day, four-night trip for the Prizewinner and one (1) guest to Las Vegas, Nevada to occur on or about Summer of 2021 (subject to change). Like all prizes \$100 or more, the winner would be subject to the winner's screening process.

B. THE PRIZE INCLUDES:

- a. Roundtrip coach airfare for up to two (2) people from any U.S. International airport to McCarran International Airport in Las Vegas (inclusive of all associated security fees, taxes and surcharges). It is the responsibility of the Prizewinner to comply with the REAL ID Act to the extent such Act is applicable to Prizewinner's air travel. - b. Ground transfers between McCarran International Airport and the destination hotel and between Contractor hosted events;
- c. Accommodations of one (1) 4-star or better hotel room for four (4) nights (double occupancy, room and room tax only);
- d. One thousand dollars (\$1,000) spending money, less any outstanding taxes and debt setoff, for the Prizewinner will be mailed as part of the Prizewinner's final travel packet via signature-required method from Contractor two (2) weeks prior to the scheduled trip departure date;
- e. Admission to the **JAMES BOND Lottery Challenge** (the "**LOTTERY CHALLENGE**") theater/venue for the Prizewinner and guest, and the Prizewinner and/or designated proxy shall have one (1) chance to participate in four (4) rounds of the **LOTTERY CHALLENGE** to win a cash prize up to one million dollars (\$1,000,000) or more. In addition, the



Prizewinner or designated proxy shall participate in a Bonus Event, to win a bonus cash prize up to one hundred thousand dollars (\$100,000) as further described in the [JAMES BOND Lottery Challenge](#) Official Game Rules; and

- f. A Prizewinner's guest may sit with the Prizewinner but will not be eligible to be a participant in the **LOTTERY CHALLENGE** unless the guest has been designated as the Prizewinner's proxy.
- C. Prizewinners will be mailed the official, detailed rules of the **LOTTERY CHALLENGE** prior to their departure.
 - D. The total amount of cash won, less tax withholdings, during the **LOTTERY CHALLENGE** by the Prizewinner will be mailed to each Prizewinner within twenty-one (21) business days after the Prizewinner's departure from Las Vegas. Contractor shall withhold from such cash prizes the minimum required federal tax withholdings and any applicable state tax withholdings and shall deposit said withholdings on behalf of the Prizewinner to the appropriate agencies. The Prizewinner shall receive an IRS Tax Form W-2G from Contractor and a copy shall be provided to the Lottery. A Prizewinner may be responsible for any additional state or federal taxes resulting from such cash prize(s), above and beyond those taxes withheld, reported and paid on the Prizewinner's behalf by Contractor to the appropriate agencies;
 - E. All prizes won by the Prizewinner on the **LOTTERY CHALLENGE** will be subject to the Lottery's debt setoff procedures;
 - F. The Prizewinner may not choose to receive the cash equivalent of the trip portion of the prize;
 - G. Upon the Prizewinner being validated by the Lottery, title to such prize shall immediately pass to the Prizewinner;
 - H. Contractor may substitute a prize of equal or better quality upon the written approval of the Lottery;
 - I. The Lottery acknowledges and agrees that each Prizewinner and their guest are subject to a background investigation prior to the event; and
 - J. Neither the Lottery nor the Contractor are responsible for the actions of any Prizewinner guest. If the Prizewinner's guest is a minor, the Prizewinner must (A) be the parent or legal guardian of such guest, or (B) must present a notarized, written consent from the minor's parent or legal guardian for the minor guest to accompany the Prizewinner on the trip.



The **JAMES BOND Lottery Challenge** is administered by MDI Entertainment, LLC and Scientific Games International, Inc. (collectively “the **Contractor**”). Any questions regarding the **JAMES BOND Lottery Challenge**, including questions regarding the assignment of proxies, prize payments, and tax liability or withholding for cash prizes, should be directed to MDI Entertainment, LLC at 1-800-201-0108. Participation in the **JAMES BOND Lottery Challenge** may be subject to other local, state, and federal laws, including the laws of the State of Nevada.

Age Limitation Rules:

While the South Dakota Lottery’s rules specify players must be eighteen (18) years or older to participate in second chance drawings, the **LOTTERY CHALLENGE** has additional guidelines as follow:

- a. The Prizewinner must be twenty-one (21) or older to participate in the **LOTTERY CHALLENGE** event. State of Nevada rules for certain venues in Las Vegas to prohibit persons under 21 to enter unless accompanied by a person 21 or older;
- b. Any Prizewinner under the age of 21 may attend the **LOTTERY CHALLENGE** if accompanied by his or her designated proxy into the State of Nevada and at all times throughout the trip;
- c. If the Prizewinner is under the age of 21, he or she must pre-designate a proxy who is 21 years of age or older to play the **LOTTERY CHALLENGE** on his or her behalf. The Prizewinner shall receive any cash prize(s) won by the proxy during the **LOTTERY CHALLENGE** (less applicable tax withholdings);
- d. If the Prizewinner is unable to participate because of age or for any other reason, you must designate a proxy;
- e. The Prizewinner may modify or change his or her proxy once he or she designates one; and
- f. In the event that the Prizewinner does not designate a proxy and a proxy is necessary for Prizewinner to participate in the **LOTTERY CHALLENGE** on his or her behalf, for any reason whatsoever, Contractor or the Lottery will appoint a proxy to play the **LOTTERY CHALLENGE** on his or her behalf. The Prizewinner acknowledges that the Proxy appointed by Contractor or the Lottery will have to make decisions on behalf of the Prizewinner and therefore, the Prizewinner delegates the power, authority or discretion to the proxy appointed by Contractor or the Lottery to make any such decisions on the Prizewinner’s behalf. The Prizewinner shall



receive any cash prize(s) won by Contractor or Lottery in the role of Prizewinner's proxy in the **LOTTERY CHALLENGE** (less applicable tax withholdings).
